1. Statement of Intent

"Providing safe and happy places to learn is essential to achieving school improvement, raising achievement and attendance, promoting equality and diversity, and ensuring the safety and well-being of all members of the school community."

(DfE, 2007).

Beis Yaakov Jewish High School is an academy in which our students flourish both academically and socially. We aim to foster a healthy and safe community where individuals take responsibility for themselves and show respect for others emphasising the importance of positive relationships amongst all members of the school community.

Beis Yaakov Jewish High School is committed to ensuring that students learn in a supportive, caring and safe environment, without fear of being bullied. Bullying is anti-social behaviour and affects everyone; it is unacceptable and will not be tolerated. If bullying does occur, all pupils should be able to tell someone and know that incidents will be dealt with promptly and effectively. Only when all issues of bullying are addressed will pupils be able to fully benefit from the opportunities available at school.

2. Definition

Bullying is any behaviour, which is deliberately intended to hurt, threaten or frighten another person or group of people. It is repeated and usually unprovoked and can continue for a prolonged period of time. It always reflects an imbalance and abuse of power. It is important that it must not be confused with the usual childhood/teenage squabbles and arguments where individuals "fall out" with one another.

Bullying can be:

- Emotional – being unfriendly, excluding, tormenting
- Physical – pushing, kicking, hitting, punching or any use of violence
- Racist – racial taunts, graffiti, gestures
- Sexual – unwanted physical contact or sexually abusive comments
- Homophobic – because of, or focusing on the issue of sexuality
- Verbal – name calling, sarcasm, spreading rumours, teasing
- Cyber – all areas of internet, such as email and internet chat room misuse. Mobile threats by text messaging and calls. Misuse of associated technology, i.e. camera and video facilities. This also includes using pseudo-images that are computer-generated images that otherwise appear to be a photograph or video.
- Disability/SEN – because of or focusing on a disability or special educational need.

- Home circumstance – targeting individuals who are looked after children or because of a particular home circumstance.

Bullying can therefore constitute any of the above activities within the context of the definition provided. Bullying may occur to anyone and this policy is inclusive of the bullying of school staff, whether by pupils, parents or other staff. (Members of the school workforce suffering from or concerned about bullying may also contact their trade union or professional association for support and advice).

Bullying can seriously damage a person's confidence and sense of self-worth, and they will often feel that they are at fault in some way. Students who are being bullied may show changes in behaviour, such as becoming shy and nervous, feigning illness or taking unusual absences. There may be evidence in work patterns, lacking concentration or truanting from school. These signs and symptoms may indicate other problems, but bullying should be considered a possibility and should be investigated.

3. Objectives:

- To prevent, de-escalate and/or stop any continuation of harmful behaviour.
- To react to bullying incidents in a reasonable, proportionate and consistent way.
- To safeguard the student who has experienced bullying and to trigger sources of support.
- To apply disciplinary sanctions to the student causing the bullying and ensure they learn from the experience, possibly through multi-agency support.

4. Policy Aims

- All students, parents, staff and governors should understand what bullying is.
- Staff and governors should follow the school policy when bullying is reported or suspected.
- All students and parents should know what bullying is and inform a member of staff if bullying arises.
- The school will always take bullying seriously. We use a range of proactive and reactive strategies to combat and prevent bullying.

5. Reporting Procedures

Students can report bullying of themselves or someone else in the following ways:

- Speaking to their Mechaneches, Year Tutor or Head of Year
- Speaking to any member of staff they feel comfortable to share this with
- Speaking to the Designated (or Deputy) Safeguarding Lead
- Year 7 can speak to their student mentor
- Speaking to a parent and asking them to pass on the information to the school.

Students are reminded that they can speak to any member of staff in school they trust

Parents/Carers can report bullying of their child or someone else's in the following ways:

- Contacting a member of their daughter's Year Team
- Contacting the Designated (or Deputy) Safeguarding Lead
- Email pastoralsupport@byjhs.org
- Importantly, parents/carers are reminded that they can speak to any member of staff in school regarding this. Staff will pass this on to the Pastoral Team.

Dealing with Reports of Bullying

If bullying is suspected or reported, the incident will be taken seriously and dealt with as quickly as possible by the member of staff who has been approached. A clear account of the incident will be recorded and passed to the Head of Year. Incidents will be escalated to senior leaders as necessary.

Heads of Year will investigate the incident by interviewing all concerned and record outcomes on CPOMS of those involved.

Year group teachers will be kept informed and asked to monitor the behaviour of the students concerned.

Parents will be kept informed and are discouraged from taking matters into their own hands and should not approach a suspected student but speak to a member of staff.

Each incident of actual or alleged bullying will be unique in its representation and its level of impact on the individuals concerned. Therefore, it is important that the school is given the opportunity to tailor a strategy to address the situation and to support the bullied student according to the particular incident/s.

Students who are victims of bullying will be offered the opportunity to discuss their experience with their Mechaneches, Head of Year or another member of staff. Students will be offered support in terms of access to the counselling to restore self-esteem and build confidence.

Students who have bullied will be helped by; discussing what happened, discovering why the student became involved and establishing a sense of wrongdoing.

Parents/carers will be informed to help change the attitude and behaviour of the student.

In agreement with both parties involved there will also be the opportunity to rebuild relationships, involving a discussion mediated by a member of staff as a way of resolving disputes.

The following disciplinary steps may be taken:

- Official warning to cease offending
- Exclusion from certain areas of the school premises or certain activities
- Isolation
- Referral to senior staff and/or external agencies e.g. Education Welfare Officer
- Internal fixed term exclusion
- External fixed term or permanent exclusion.

Pupils who have been bullied will be supported by:

- Discussing what happened.
- Reassuring the pupils who have been bullied
- Reassuring the young person that they are not responsible
- Reassuring the young person that the school deals robustly with bullying and that steps are in place to prevent the bullying from reoccurring
- Referral and access to a school counsellor if required
- Offering restorative justice meetings to build relationships and create positive outcomes
- Referral and access to a school counsellor if required

6. Prevention

As a school we take bullying seriously. We use a range of proactive strategies to prevent bullying. These include;

- Effective school leadership that promotes an open and honest anti-bullying ethos.
- Use of curriculum opportunities, in particular tutor periods and PSHE classes where issues of diversity are discussed and anti-bullying messages are drawn out.
- Anti-bullying workshops

- Use of opportunities throughout the school calendar and at certain times of the school day to raise awareness of the negative consequences of bullying e.g. Anti-Bullying Week in November of each year
- Whole school assemblies
- Pupil surveys
- Poster campaigns
- Improved supervision in potential problem areas
- Peer mentoring
- Staff training reflects the anti-bullying policy and practice of the school.

7. Development, Monitoring and Review

We plan to:

- Monitor, evaluate and review our anti-bullying policy on a regular basis led by the Head Teacher (Pastoral)
- Support staff to identify and tackle bullying appropriately.
- Ensure that students are aware that all bullying concerns will be dealt with sensitively and effectively and seek feedback from students via the Student Council and annual student questionnaires.
- To learn from anti-bullying good practice elsewhere and utilise the support of other organisations when appropriate.

This policy will be reviewed annually by the Head teacher of Personal Development and Culture with the SLT. At every review, the policy will be approved by the full governing board.
