What additional support can be provided in the classroom?	<p>The following support applies in both the Kodesh and the Chol lessons:</p> <ul style="list-style-type: none"> <li>• Class teachers use adaptive teaching to ensure all pupils are learning.</li> <li>• Teaching assistants (TA) work in class to support targeted students. They also support learning for small groups in core subjects.</li> <li>• TAs deliver interventions 1:1 and to targeted groups</li> <li>• Learning is supported by additional, specific resources</li> <li>• Use of laptops including speech-to-text and text-to-speech software</li> <li>• Coloured paper/overlays for visual processing</li> <li>• The HUB is our venue for individual learning and targeted support and interventions. It is a safe, pleasant and purposeful learning environment.</li> </ul>

What provision do you offer to facilitate access to the curriculum and to develop independent learning?</p>	<ul style="list-style-type: none"> <li>• Our schemes of work are designed to be suitable for different ability levels.</li> <li>• We access external agencies to provide support on a needs basis including LSS (learning support service), SaLT (speech and language therapy), PT (physiotherapy) and OT (occupational therapy).</li> <li>• Use of CATs, WRATs and other assessments to identify learning needs.</li> <li>• We use additional computer-based resources such as IDL and Mathswatch to support independent skills in core subjects. We also use Docsplus and similar applications to facilitate learning and self-expression.</li> <li>• Our School Counsellor, Mrs Rechnitzer and school psychologist Mrs Sher work closely with students and staff</li> <li>• We have a service level agreement with 42<sup>nd</sup> Street, providing an additional counsellor</li> <li>• We work with the Salford EP service; our school educational psychologist is Dr Jackie Lydon</li> <li>• We work with the Salford Learning Support Service to develop strategies to support young peoples' learning and wellbeing in school.</li> </ul>

<p>1. What handover arrangements will be made at the start and end of the school day? Do you have parking areas for pick up and drop offs?</p>	<ul style="list-style-type: none"> <li>• Hand rails have been installed leading to the pupil entrance to assist pupils with physical disabilities.</li> <li>• There is a large parking area in front of the school for those who are unable to access the school through the usual pupil entrance.</li> <li>• Parking facilities available including two bays for the disabled and a large disabled drop-off area.</li> <li>• Staff available to accompany children in and out of school when necessary.</li> </ul>

	<ul style="list-style-type: none"> <li>• Where necessary, parents can call into school to request pupil meet and greet</li> <li>• Security guards located on the premises at all times to ensure that no unauthorised exits occur.</li> </ul>
2. How do you work with the family to draw up a care plan and ensure that all relevant staff are aware of the plan?</p>	<ul style="list-style-type: none"> <li>• A meeting is held with the parent/carer, SENCO and any other professional who is involved with the YP.</li> <li>• The Care plan is then shared with all staff in a briefing and monitored by the SENCO or key worker every half term or sooner if needed,</li> <li>• Parents are consulted should there be any adjustments made to the plan.</li> <li>• Parents can contact the SENCO if they feel the plan needs to be amended.</li> </ul>
<p>3. What would the school do in the case of a medical emergency</p>	<ul style="list-style-type: none"> <li>• Call 999 and Hatzoloh (paramedics).</li> <li>• Contact a qualified first aider. There are a number of qualified first aiders in school</li> <li>• Contact parent/carer, collect them or pay for a taxi if required</li> <li>• In absence of parent/carer a first aider would accompany the pupil to the hospital.</li> </ul>
<p>4. How do you ensure that staff are trained/qualified to deal with a child's particular needs?</p>	<ul style="list-style-type: none"> <li>• All staff are trained in Safeguarding/Child protection</li> <li>• Regular first aid training is offered and we have a number of trained first aiders. Lists of trained first aiders are updated regularly and posted prominently around the school</li> <li>• We have staff trained in use of EpiPen's and asthma management.</li> <li>• Several staff including teaching, pastoral, office staff and support staff are trained Mental Health First Aiders</li> <li>• We have a Service provider agreement with the school nurse who gives training as required. Our school nurse is Gwenno Rhys</li> </ul>

Which health or therapy services can children access on school premises?</p>	<ul style="list-style-type: none"> <li>• We have provided accommodation for any services that a pupil requires including counselling and psychological services, speech and language therapy, lego therapy and social skills support, etc</li> </ul>

<b>Communication with Parents</b>

How do you ensure that parents know "who's who" and who they can contact if they have concerns about their child/young person?</p>	<ul style="list-style-type: none"> <li>• Parents are provided with an information pack during the Summer holidays.</li> <li>• Timetables are distributed on the first day of term.</li> <li>• Pupils are given information about their year team who will be a point of contact for Parents.</li> </ul>
<p>2. Do parents have to make an appointment to meet with staff or do you have an Open-Door policy?</p>	<ul style="list-style-type: none"> <li>• Parents can contact staff via the school office. It is not always possible to speak immediately to a member of staff, if they have teaching commitments at that time.</li> <li>• All parent calls are returned as swiftly as possible; this is usually within 48 hours of initial contact. For part-time staff, this will be on the next day they are in school.</li> <li>• Parents are asked only to contact teachers during the school day and not at home or after school hours.</li> <li>• The SENCO can be called at any time during the school day.</li> </ul>
<p>3. How do you keep parents updated with their child/young person's progress? What opportunities do you offer for pupils to have their say? e.g. school council	<ul style="list-style-type: none"> <li>• There is a school council in place that feedback to SLT regularly throughout the year.</li> <li>• Pupils meet their mechaneches (pastoral tutor) for individual meetings at least once a term and year teams and pastoral staff are available at breaktimes.</li> <li>• There are multiple and regular interactions with staff on an informal basis and pupils meet regularly with members of the Year team.</li> <li>• Several post-boxes have been stationed around the school for pupils for provide their feedback.</li> <li>• Students with an EHCP may have a key worker to support them in expressing their views</li> <li>• Pupil surveys are held on a regular basis</li> </ul>

<p>1. Do you offer help with completing forms and paperwork? If yes, who normally provides this help and how would parents access this?</p>	<ul style="list-style-type: none"> <li>• Yes, SENCO or Deputy SENCO would arrange to meet with the parents/carers and help them complete all the necessary paper work.</li> <li>• Parents are offered this help by phone as well as in person.</li> </ul>
<p>2. What information, advice and guidance can parents and young people access through the school? Who normally provides this help and how would they access this?</p>	<ul style="list-style-type: none"> <li>• YP and families can get support from the school nurse via the SENCo or school office.</li> <li>• We work with Early Help to signpost organisations who can support on a variety of issues including finance, young carers etc</li> <li>• Services such as LSS/MCEDs will work with families of young people who are referred to them. Referrals/signposting usually through the SENCO</li> <li>• From Year 10, Connexions, representatives from local colleges and/or local Authority representatives attend Annual Reviews of EHCPs.</li> </ul>

How does the school help parents with travel plans to get their son/daughter to and from school?</p>	<ul style="list-style-type: none"> <li>• This issue has not arisen as almost all the pupils live within a short walk of the school. Those who live further away have arranged their own transport.</li> </ul>

<p>1. What support does the school offer for year 6 pupils coming to the school? (e.g. visits to the school, buddying)</p>	<ul style="list-style-type: none"> <li>• Handover meetings are held with all feeder primary schools</li> <li>• Girls and their parents come to school for an interview with the Headteacher and have a chance to raise any concerns about transition to high school.</li> <li>• Girls are asked who they would like to be with in class and this is considered when forming the class lists.</li> <li>• Year team and SENCO is available around school if there are any initial difficulties.</li> <li>• Year team and SENCO can be telephoned by parents with any concerns.</li> <li>• Pastoral care available</li> <li>• School counsellor visits feeder schools to discuss the peer mentoring system to the incoming Year 7 pupils.</li> <li>• Peer mentoring – Year 10 girls trained by school counsellor to mentor Year 7 girls when they enter school.</li> </ul>
<p>2. What support is offered for young people leaving the school? (e.g. careers guidance, visits to colleges, apprenticeships, supported employment etc)</p>	<ul style="list-style-type: none"> <li>• Advice and support are given by the school's careers advisor who meets all year 11 girls for an interview. We offer a range of options all in keeping with the ethos of the school and parents' wishes. See school website for the careers policy <a href="http://www.byjhs.org">www.byjhs.org</a></li> <li>• Most of our pupils continue their education in Jewish Seminary for further education, where they complete A Levels, Btechs, NVQs etc in addition to continuing their Jewish studies.</li> <li>• Relevant staff advise regarding suitable Seminaries or other alternatives. (Many Seminaries provide vocational training and careers advice.)</li> </ul>
<p>3. What advice/support do you offer young people and their parents about preparing for adulthood</p>	<ul style="list-style-type: none"> <li>• Constant reminders about the importance of good attendance and punctuality, literacy and numeracy, behaviour and attitude for the world of work and to be happy in personal life.</li> <li>• Representatives from different sectors speak to the girls about their careers.</li> <li>• Activities from local banks teach girls about finance and financial responsibility</li> <li>• Preparation for Transition lessons undertaken by high needs pupils to assist them with vital life skills, e.g. Independent living, independent travel, budgeting, road safety, etc.</li> <li>• Girls are encouraged and taught to be productive members of society and to fulfil their abilities and ambitions by gaining a useful education and to have good self knowledge so that they are aware of their own strengths and talents.</li> </ul>

	<ul style="list-style-type: none"> <li>• Advice is given to vulnerable pupils and their parents regarding stranger danger etc.</li> <li>• School staff provide good role models of behaviour to pupils by the way they treat each other and the girls.</li> <li>• Guest speakers and special events to encourage positive hashkofos and good middos.</li> <li>• Mechanchos speak to their form weekly to encourage good middos and approach to life.</li> <li>• Weekly PHSE lessons are delivered by Mechanchos or speakers from outside agencies eg school counsellor</li> </ul>
<b>Extra-Curricular Activities</b>	
<p>1. Do you offer school holiday and/or before and after school provision? If yes, please give details.</p>	<ul style="list-style-type: none"> <li>• We run various events out of school hours throughout the year coinciding with the Jewish festivals.</li> </ul>
<p>2. What lunchtime or after school activities do you offer? Do parents have to pay for these and if so, how much?</p>	<ul style="list-style-type: none"> <li>• Lunchtime club: provides a place to go for those who find lunchtime challenging</li> <li>• Melave Malka</li> <li>• School show</li> <li>• Regular year group socials such as quiz evenings, dancing and a variety of fun activities</li> <li>• Parents do not have to pay for the majority of these events</li> <li>• Numerous special programmes during the school day where one year or the whole school goes off timetable and has a creative, fun and educational activity. These are usually based around the Jewish festivals.</li> <li>• Parents are asked to make a small voluntary contribution at the beginning of the year, to offset some of the cost of special events.</li> </ul>

<p>3. How do you make sure clubs, activities and residential trips are inclusive?</p>	<ul style="list-style-type: none"> <li>• Risk assessments are carried out, and extra staff will accompany a trip if needed.</li> <li>• Before trips and activities, targeted students (e.g. quieter, more vulnerable, or with SEND) given the opportunity to discuss their needs, and what would help them feel safe.</li> <li>• Experienced, trained TAs accompany most trips out and have a target pupil list.</li> <li>• Extra TA support is provided on a trip where necessary.</li> <li>• There is a school choir, tzedoko team and chesed team, as well as social and programming teams. Pupils decorate the Succoth at Heathlands and decorate Beenstock Home every Yom Tov.</li> <li>• All these groups carefully select participants to ensure maximum inclusion of all pupils.</li> <li>• Extra-curricular activities are in groups which are carefully designed for inclusivity.</li> <li>• For social events, parallel programming is in place, led by students, for pupils who need a different style activity.</li> </ul>
<p>4. How do you help children and young people to make friends?</p>	<ul style="list-style-type: none"> <li>• A circle of Friends may be organised for the more vulnerable pupils.</li> <li>• Pupils are reminded about the importance of inclusion.</li> <li>• Support from the Pastoral care team in school.</li> <li>• The girls will learn befriending techniques with the school counsellor</li> <li>• Year team arrange for girls to include a girl in their break time activities</li> <li>• Social skills sessions for targeted pupils.</li> </ul>

## Glossary

	<b>Adaptive Learning</b>	Adaptive teaching is a style of teaching where teachers “adapt teaching to respond to the strengths and needs of all pupils” (DfE 2011). Teacher make slight modifications to the lesson content or delivery based on the needs of the pupils in their class.
	<b>Annual Review</b>	All and Education, Health and Care Plans must be reviewed annually. The Annual Review ensures that that once a year the parents, the pupil, the Local Authority, the school and all professionals involved consider the progress the pupil has made over the last 12 months, and whether amendments need to be made to the Education, Health and Care Plan.
<b>ADHD/ADD</b>	<b>Attention Deficit Hyperactivity Disorder/Attention Deficit Disorder</b>	ADHD/ADD is a disorder that appears in early childhood. ADHD/ADD makes it difficult for students to hold back their spontaneous responses (responses can involve everything from movement to speech to attentiveness). Students with ADD are not diagnosed as having excessive hyperactive behaviour but display all other symptoms. Children with ADD/ADHD may be: Inattentive, hyperactive, and impulsive (the most common form) <ul style="list-style-type: none"><li>· Inattentive, but not hyperactive or impulsive.</li><li>· Hyperactive and impulsive, but able to pay attention.</li></ul>

	<b>Assessment</b>	<p>This involves building a picture of your child's abilities, difficulties, behaviour, his/her special educational needs and the support required to meet those needs. Assessment is an important part of deciding whether your child's progress rate is as good as is expected. Teachers carry out routine assessments regularly. More specialised assessments may be required if progress is not at an expected rate. This may be carried out by the SENCO, an Educational Psychologist or an Advisory Teacher.</p> <p>A statutory assessment is a formal procedure which involves the collection of information from as many people as possible who have detailed knowledge about your child. This may lead to the issue of a statement of special educational needs.</p>
	<b>Asperger Syndrome</b>	<p>An autistic spectrum condition characterised by difficulties with social interaction, social communication and inflexible thought patterns in an otherwise intelligent and able child.</p>
<b>ASD/C</b>	<b>Autistic Spectrum Disorder/Condition</b>	<p>Autistic spectrum conditions are characterised by difficulties interacting and communicating.</p> <p>The characteristics of autism can be described as the 'triad of impairment':</p> <ul style="list-style-type: none"> <li>· Socialisation – poor social skills;</li> <li>· Communication – difficulties with speech language and communication;</li> <li>· Imagination – rigid thought and resistance to change.</li> </ul> <p>The commonly used terms 'autism' and 'Asperger syndrome' are autistic spectrum conditions.</p>
<b>C &amp; L</b>	<b>Literacy Support</b>	<p>Pupils with a reading age 2 years below their chronological age attend extra literacy sessions to boost their reading scores and improve their access to the curriculum and their ability to be successful in GCSE exams.</p>
	<b>Clinical Psychologist</b>	<p>Clinical Psychologists help parents and children who are experiencing emotional and/or behavioural difficulties in their home environment.</p>

	<b>Code of Practice</b>	The SEND Code of Practice (often referred to as 'The Code') gives practical guidance on how to identify, assess and support children with special educational needs. All early education settings, state schools and Local Education Authorities must take account of this Code when they are dealing with children who have special educational needs.
	<b>Connexions</b>	Connexions provide a targeted service to anyone aged between 13 and 25 who has a statement of SEND or an Education, Health and Care Plan (EHCP) where it is deemed that special educational provision in it is still needed. They support in the transition from school to further education opportunities, work or training.
	<b>Differentiation</b>	Differentiation is the adjustment of the teaching methods and/or resources according to the learning needs of the pupils. It can be aimed at the groups within the class or individuals. See also personalised learning.
	<b>Differentiated Curriculum</b>	A curriculum that is specially adapted to meet the special educational needs of individual children.
	<b>Dyscalculia</b>	Children with dyscalculia have difficulty in acquiring mathematical skills. Children may have difficulty understanding simple number concepts, lack an intuitive grasp of numbers and have problems learning number facts and procedures. Dyscalculia is a type of Specific Learning Difficulty (SpLD). See under SpLD below.
	<b>Dysgraphia</b>	Dysgraphia makes the act of writing difficult. It can lead to problems with spelling, poor handwriting and putting thoughts on paper. People with dysgraphia can have trouble organising letters, numbers and words on a line or page. This can result partly from trouble processing what the eye sees (visual-spatial difficulties) or trouble processing and making sense of what the ear hears (language processing difficulties).

	<b>Dyslexia</b>	Children with dyslexia have a marked and persistent difficulty in learning to read, write and spell, despite making good progress in other areas. Areas of difficulty include: working memory, organisation, reading comprehension, handwriting, punctuation, concentration, sequencing words and numbers. Students with dyslexia may also mispronounce common words or reverse letters and sounds in words. Dyslexia is a type of Specific Learning Difficulty (SpLD). See under SpLD below
	<b>Dyspraxia</b>	A disorder that affects the co-ordination of movement. This can affect co-ordination of the speech organs (oral dyspraxia) or other actions e.g. eating, dressing or writing. Dyspraxia is a type of Specific Learning Difficulty (SpLD). See under SpLD below.
<b>EHCP</b>	<b>Education, Health and Care Plan</b>	From 1 <sup>st</sup> September 2014, Education, Health and Care Plans (EHCPs) will be issued instead of statements of SEND. Existing statements will be converted to EHCPs over the next three years. An EHCP has the same statutory protection as a statement but it can be issued at and maintained to any point from birth to the age of 25. The criteria and procedure for securing an EHCP for your child is detailed as part of Salford's Local Offer.
<b>EP</b>	<b>Educational Psychologist</b>	Most, but not all, Educational Psychologists are employed by local authorities (LAs). Their main work is with schools and pre-school settings to provide advice, support and staff training for children with SEND. They may perform assessments of children with SEND and produce a report as part of the statutory assessment.
	<b>Exam Special Arrangements</b>	Special arrangements can be made for pupils who are disadvantaged during exams because of certain difficulties such as dyslexic tendencies. Readers, scribes and or extra time can be arranged, for pupils who meet the exam board criteria, in order that the disadvantage they have can be redressed.
	<b>Exam Special Concessions</b>	Special concessions can be arranged for pupils who qualify for these e.g. the exam paper can be enlarged or written in Braille for pupils with visual difficulties or a scribe can be used if a pupil breaks an arm before the exam etc.



	<b>Governors</b>	Each school has a board of Governors that is responsible to parents, funders and the community for making sure the school provides a good quality education. In Academy schools the governors are often called directors.
<b>HI</b>	<b>Hearing Impairment</b>	Children with a hearing impairment range from those with a mild hearing loss to those who are profoundly deaf. They cover the whole ability range. For educational purposes, children are regarded as having a hearing impairment if they require hearing aids, adaptations to their environment and/or particular teaching strategies in order to access the concepts and language of the curriculum
	<b>Inclusion</b>	Inclusion is the process by which schools and other establishments change their principles, policies, practices and environments to increase the presence, participation and achievement levels of children with special educational needs and/or a disability.
<b>IEP</b>	<b>Individual Education Plan</b>	An IEP sets out the special help that a child will receive at school or early years setting to meet his or her special educational needs (SEND). It is not a legal requirement for your child to have an IEP but it is good practice for parents and the child to be involved in drawing it up and reviewing it if there is one. An IEP should be reviewed regularly and at least twice a year. If there is no IEP the school should have another method of recording how it is meeting your child's SEND
<b>LD</b>	<b>Learning Difficulties</b>	A child has learning difficulties if he or she finds it much harder to learn than most children of the same age.
<b>LEA</b>	<b>Local Education Authority</b>	Each council has an LEA. The LEA is responsible for the education of all children living within the council's area and has some responsibility for all state schools in our area. In Salford, the LEA is combined with the children's social services departments and is known as Children's Services. Children's Services have the same responsibilities for educational provision for children with special educational needs as LEAs.

<b>MLD</b>	<b>Moderate Learning Difficulties</b>	Children with moderate learning difficulties have much greater difficulty than their peers in acquiring basic literacy and numeracy skills and in understanding concepts. They may also have associated speech and language delay, low self-esteem, low levels of concentration and under-developed social skills.
	<b>National Curriculum</b>	This sets out a clear, full and statutory entitlement to learning for all children, setting out what should be taught and setting attainment targets for learning. It also determines how performance will be assessed and reported. The national curriculum is taught in a way that meets the needs of individual children, e.g. setting goals that are achievable.
	<b>National Curriculum Inclusion Statement</b>	A detailed statement within the national curriculum, setting out the principles that schools must follow, to make sure that all children have the chance to succeed.
	<b>OFSTED</b>	OFSTED stands for the Office for Standards in Education. OFSTED is the inspectorate for children and learners in England and they oversee the quality of the provision of education and care through inspection and regulation. They inspect childcare providers, schools, colleges, children's services, teacher training and youth work.
	<b>Personalised Learning</b>	Personalised learning is about tailoring education to meet individual needs, interests and aptitudes to ensure that every pupil achieves and reaches the highest standards possible, no matter what their background or circumstances or level of ability
	<b>Phonics</b>	A system of teaching reading and spelling that stresses basic symbol-sound relationships and how this works in decoding words.
	<b>Phonological Difficulties</b>	A child with phonological difficulties finds it hard to select and use the correct sounds necessary for speech.

<b>PD</b>	<b>Physical Difficulty</b>	<p>There is a wide range of physical disabilities and pupils cover the whole ability range. Some children are able to access the curriculum and learn effectively without additional educational provision. They have a disability but do not have a special educational need. For others, the impact on their education may be severe. In the same way, a medical diagnosis does not necessarily mean that a child has SEND. It depends on the impact the condition has on their educational needs.</p> <p>There are a number of medical conditions associated with physical disability which can impact on mobility. These include cerebral palsy, heart disease, spina bifida and hydrocephalus, muscular dystrophy. Children with physical disabilities may also have sensory impairments, neurological problems or learning difficulties. Some children are mobile but have significant fine motor difficulties which require support.</p>
	<b>Physiotherapists</b>	Physiotherapists see children who have difficulties with movement (e.g.: walking, kicking a ball). The therapist will assess the child's movements and identify what the physical problems are and then devise a treatment plan.
	<b>Responsible Person</b>	The person (either the member of SLT, chair of the governing body or SEND Governor), who has responsibility for making sure that staff know about a child's SEND
<b>SENCO</b>	<b>Special Educational Needs Co-Ordinator</b>	A Special Educational Needs Co-ordinator or SENCO is a teacher who has the responsibility for overseeing the day-to-day SEND provision within his or her school. The SENCO and your child's teacher/s should work together to plan how his/her needs should be met.
	<b>Special Educational Provision</b>	The special help given to children with special educational needs which is additional to or different from the provision generally made for other children of the same age.
<b>SpLD</b>	<b>Specific Learning Difficulties</b>	See Dyslexia, Dyscalculia and Dyspraxia above.

<b>SEND</b>	<b>Special Educational Needs</b>	Children with special educational needs have significantly greater difficulty in learning than most children of the same age or have a disability. These children may need extra or different help from that given to other children of the same age. Approximately one fifth of all children may have a SEND at some point in their school career.
	<b>Special Educational Needs (SEND) Code of Practice</b>	See 'Code of Practice' above.
	<b>Specialist Assessor</b>	The specialist assessor is qualified to carry out the necessary assessments required for access arrangements. The Senco is currently the school's special assessor.
	<b>Statutory Assessment</b>	This is the legal process for producing an Education, Health and Care Plan (EHCP). Parents, a young person over the age of 16 who is deemed capable and a variety of professionals can request a statutory assessment. Parents and/or the young person themselves if they are deemed capable, must give their permission for this to go ahead. Not all Statutory Assessments result in the issuing of an Education, Health and Care Plan. From September 2014, Statutory Assessment can be carried out at any time between a child's birth and the age of 25, although there will be very few young people undergoing the process for the first time beyond the age of 16.
<b>TAs</b>	<b>Teaching Assistants</b>	Almost all schools now employ teaching assistants to support whole classes, small groups or individual pupils. Teaching assistants may be called other things, such as learning support assistant (LSA) or special support assistant (SSA) particularly if they support a child with special needs.

	<b>Transition</b>	Transition is when a child moves from one setting to another, such as from home to a childminder, to nursery, to primary school, to secondary school, or from education into adult life. Planning for transition is important if your child has a significant level of need where advance preparations may need to be made in the new setting to ensure it is successful.
	<b>Transition Plan</b>	If your child has a statement of SEND that has not yet been converted in to an Education, Health and Care Plan (EHCP), the annual review in year 9 (and any subsequent annual reviews until the young person leaves school) must include the drawing up and subsequent review of a Transition Plan. The Transition Plan should draw together information from a range of professionals within and beyond the school in order to plan for the young person's transition to adult life. If your child has an EHCP, the Transition Plan is replaced by a 'Preparing for adulthood' review (see above).
<b>VI</b>	<b>Visual Impairment</b>	Vision loss to such a degree that additional support is required. Refers to people with irretrievable sight loss and does not include those whose sight problems can be corrected by spectacles or contact lenses, though it does include those whose sight might be improved by medical intervention. This simple definition covers a wide spectrum of different impairments.
